

## Editorial



*The armed conflict between Israel and Lebanon, actually between Hezbollah and Israel, began on 12 July 2006 after a cross-border raid by Hezbollah militia capturing two and killing three Israeli soldiers. Hezbollah's purpose was to persuade Israel to fulfil a promise to free the prisoners and detainees held in Israeli prisons. Israel held the Lebanese government responsible for the attack and described the kidnapping as an act of war that is contrary to international law. This led to Israel's massive military response by air, land and sea on southern Lebanon which resulted in extensive civilian casualties and vital infrastructure losses. In fact, it ended in cutting off the southern territory of Lebanon from the outside world, causing a humanitarian catastrophe. The conflict has resulted in the death of hundreds of people, mostly Lebanese civilians, and displaced more than a million Lebanese and disrupted normal life across much of Lebanon.*

*In retaliation, Hezbollah continuously launched rocket attacks into northern Israel and confronted with the Israeli army on the ground with hit-and-run guerrilla attacks. Hezbollah's rockets killed a number of Israeli civilians and caused the displacement and withdrawal to bomb shelters of more than half a million civilians.*

*Attacks by Israel on civilian population centres and infrastructure have drawn sharp criticism internationally. The aggressive actions of the Israeli forces are against all norms of civilized behaviour and are contrary to accepted norms of international law. To claim that this massive use of force, principally against civilians, is an act of self-defence is as outrageous as the USA saying that it attacked Iraq and Serbia in self-defence. To compound matters, the manner in which the Israeli forces conducted these operations is wholly against the letter and spirit of International Humanitarian Law.*

*Determining that the situation in Lebanon constitutes a threat to international peace and security, the UN Security Council adopted a resolution (S/RES/1701, 2006), that called for a permanent ceasefire and a long-term solution to the conflict. The conditions that led to the current crisis should not be allowed to continue. In order to establish peace in the region, it is necessary to work towards evolving a concrete plan to achieve a permanent solution to this vexed problem.*
